

# **Brief History**


- Founded in 1990 as a direct response to humanitarian crisis prompted by the civil war
- Constituting of two national umbrella institutions of Christians and Muslims
- Initiated direct dialogues with the warring parties
- Mobilized regional and international support for cease fire and round table negotiations
- Finally, succeeded in 2003 to bring about a comprehensive peace accord after 14 years of struggle.
- Intervened in over ½ dozens of situations that threatened the peace
- Now serves as the government and the UN mission's #1 partner in conflict resolutions in Liberia

- Successful intervention in constitutional crisis between the lower house of Liberian Parliament and the Supreme Court of Liberia
- Signing of Communiqué to support demographic dividend
- Signing of anti corruption communiqué

#### Lessons Learned

- Mutual respect, trust building and internal harmony are key for successful interfaith initiatives
- Religion and State collaboration can achieve a lot on sensitive development issues
- Interfaith collaboration during humanitarian crisis can serve as an eye opener and bridge that brings followers of different faith mush more closer
- Avoiding sensitive doctrinal issues that might undermine the mutual trust

### Recommendations

- For interfaith collaboration to succeed you must have common interest (humanity), promote shared values
- Working with the State is very essential but neutrality must not be compromised as it is a key pillar of your authority
- Attract youth's participation through capacity building, scholarships, conferences as they will be the ones to take over after you.
- Involvement of women's participation in decision making at all level.
