

Localizing Response to Humanitarian Need: THE ROLE OF RELIGIOUS AND FAITH-BASED ORGANIZATIONS

BRIEF SUMMARY REPORT ON FORUM ON LOCALIZING HUMANITARIAN RESPONSE

Dear Colleague:

The [Forum on Localizing Response to Humanitarian Need](#) as held Oct 16-19 this past week in Colombo, Sri Lanka. The Forum was organized as a follow on from the World Humanitarian Summit, responding to and reinforcing the localization of aid/Grand Bargain discussions, and designed to produce a body of evidence on questions of HOW to engage local faith actors, and actions to scale up their engagement as local partners.

[142 people from 36 countries](#) assembled to learn from Sri Lankan religious leaders and FBOs and from each other about local faith engagement in humanitarian response, and to discuss how to scale up engagement. About 40 local actors received a subsidy to attend.

[The local host committee](#), co-chaired by Venerable Banagala Upatissa Thero and Rev Ebenezer Joseph, brought forward many inspiring examples of courageous inter-religious leadership and effective collaboration on peacemaking and post war reconciliation, recovery from the 2004 Tsunami and other humanitarian situations. We learnt a great deal about how the religious leaders and faith communities work together, and how they coordinate with faith based and secular NGOs, both local and international, and governmental bodies. As the Planning Committee had hoped when they selected Sri Lanka as the site of the Forum, there was indeed much to learn from the Sri Lankan experiences about how local faith actors can contribute to sustainable peace and to disaster preparedness and recovery.

The Forum resulted from an intensive yearlong collaboration between the Sri Lankan host committee and [the International Planning Committee](#) consisting of diverse international faith networks. Under the leadership of the Partnership for Faith and Development, the organizing partners worked collaboratively to secure high rates of participation by local faith actors in the Forum, to create a rich evidence base, and to secure the [funding needed to stage the event](#). USAID's early backing gave us the confidence to go full steam ahead on the planning, and many faith based networks and the GHR Foundation contributed the rest of the funding required.

During the Forum panels on the Contributions of Religion and FBOs to 6 themes of humanitarian response formed the basis for a rich exchange of information, and the development of specific recommendations for scaling up LFA engagement. Panel topics included Peace and Conflict, Disaster Response, Disaster Risk reduction and Prevention, Refugees and Forced Migration, Children and Health and Gender-based Violence.

In addition to diverse religious leaders and FBO, both local and global, many academic and secular participants contributed their research and technical resources [to the learning exchange](#).

Intergovernmental organizations gave helpful inputs and guidance to the Forum also. From bilateral: Sri Lanka, USA, Australia, Germany; and multilaterals: the UN Resident Coordinator, World Food Program, UNHCR, UNICEF. It was especially helpful to have Una McCauley (UNRC Sri Lanka) give remarks at both the opening and closing of the Forum.

Forum participants expressed clear interest in informing ongoing governmental negotiations regarding the reform of the Humanitarian system and localization of aid, as well in aligning with ongoing advocacy processes both global north e.g. Charter4Change, and global south e.g. NEAR network. A draft Call to ACTION was discussed. An ongoing Advocacy Working Group was formed with about 30 members, and plans for finalizing the Call to ACTION and an ACTION plan are underway.


