Dear Friends,

On behalf of the Board of Directors I am delighted to introduce another Annual Report on what has been a bold and brave year for the Joint Learning Initiative.

Our learning network is anchored in the experience of grassroots leaders across international regions, which draws on specialist input from researchers and practitioners in the field of religions in development. Collectively, we continue to witness the critical issues of

extreme poverty and climate change in a complex and contested global landscape. JLI's work with its members recognizes the interconnectedness of these challenges. We collect and share knowledge and learnings as evidence evolves, bringing impact to the work of faith communities as they implement solutions to address the issues.

UN data indicate that despite significant progress in reducing global poverty rates, millions still live in extreme poverty, lacking access to basic necessities such as food, clean water, and healthcare. The escalating climate crisis poses a threat to both human well-being and environmental sustainability. JLI's need to advocate for an integrated approach that recognizes the linkages between local movements and local faith communities to end poverty reduction and climate action is now. Building on work grounded in 2022 and 2024, the Board Directors aligned JLI's strategy to focus on JLI's State of the Evidence and Fair and Equitable efforts as strategies to strengthen partnerships between local faith actors, governments, religious and international organizations.

Responding to the call to decolonize development, we are prioritizing localized programme design work that promotes the lived experience as research equity to advance the SDGs into the next generation. With the

FAIR & EQUITABLE APPROACH

In 2023, we expanded our work on the Fair & Equitable Approach, which seeks to transform JLI's research and partnerships by challenging unjust power dynamics in knowledge production in religions and development.

This year we continued to support the work of JLI's existing Regional Learning Hubs in East Africa, Syria, and the Middle East, as well as supporting the establishment of two new Regional Hubs in South East Asia and Southern Africa. JLI also began work on creating a set of Guiding Principles for a Fair & Equitable JLI - a framework for implementing fair and equitable practices across the JLI.



East Africa Hub on Governance, Peacebuilding, and Local Faith Actors

In January 2023, the co-chairs of the East Africa Hub, John Okanga and Professor Fredrick Ogenga took part in the Hidden Peacebuilders Network research planning and networking meeting in Bujumbura, Burundi. During the meeting, they presented the work of the East Africa Hub, receiving valuable feedback and strengthening networks with colleagues from East Africa, Europe, Latin America, South and South East Asia.

In May 2023, the East Africa hub held an online roundtable for Hub members exploring the role of religious communities in post-election reconciliation in Kenya. Hub members Dr. Seith Abeka (University of Nairobi), Nyambura Mundia (Usawa Inc.) and Siyama Ismail (The Muslim Centre for Peace and Reconciliation) opened the conversation by sharing their experiences working with Christian and Muslim communities in Kenya during recent political instabilities. Hub members were then invited to share their experiences of the issues across the region.

Alvin Andanje (JLI's FPCC Coordinator, Africa Region) was in attendance and summarized many of the key points addressed during the session in <u>a blog post on the JLI website.</u>

Throughout 2023, the East Africa Hub continued to collaborate on the Hub's first scoping study report "Bridging the Gaps: The Work and Evidence Generation of Faith Actors on Peacebuilding and Governance in East Africa". In preparation for publication, and in line with JLI's commitment to fair, equitable and participatory research methodologies, the East Africa Hub will convene a series of Listening Dialogues in early 2024 to facilitate discussion among Hub members about the report's findings, prior to publication of the report in 2024.

Middle East Hub on Monitoring, Evaluation, Accountability, and Learning (MEAL) and Faith

The Hub experienced several challenges in 2023, such as the catastrophic earthquake in Türkiye and Syria in February 2023, as well as the outbreak of the Israel/Gaza war and the bombing of southern Lebanon by Israel from October 2023 onwards, all of which affected several Hub members and disrupted plans for an in-person Hub meeting in 2023. The Hub's activities were also affected by the departure of JLI's previous Middle East Regional Coordinator, Zainab Chamoun, in early 2023.

However, in June 2023 JLI welcomed a new Middle East Regional Coordinator, Mira Neaimeh, who, like Zainab, has extensive knowledge and experience of working with faith actors in the region.

Working with the Middle East Hub cochairs, Ana Maria Daou and Dr.
Mohammad Abo Hilal, JLI has worked to resume planning for the Hub and connect with actors and practitioners in the region as they explore how MEAL is practiced in partnership with faith actors.

In October 2023, the Middle East Hub held a virtual meeting where members were able to reconnect with each other and the Hub leadership.

The meeting showcased a summary of previous achievements, as well as the current and future aspirations of the Hub. Hub members also discussed the achievements and activities of their respective organizations during the past period. Members welcomed the new coordinator, as well as the continuation of the hub's activities for the benefits it holds for each one of them personally as well as the organizations they represent. It was agreed during the meeting to keep our regular meeting once every two months to ensure communication and cohesion between hub members.

A second meeting took place on 22 December, which hub members used to update each other about their current situation and activities and to plan for the hub's first practice guide on MEAL and faith in the Middle East.

Plans are now underway for the first in-person Hub meeting to take place in Istanbul in February 2024.

<u>Syria Hub on Mental Health & Psychosocial Support (MHPSS) &</u> Culture

Hub Leadership

The Syria Hub (as well as the Middle East Hub) faced severe disruption in early 2023 as JLI's partners in the region were affected by the 6 February earthquake. Fortunately, all of our colleagues survived however several of them were displaced and others were exposed to new layers of trauma and grief. After a break of several weeks, the Hub resumed activities.

By the end of May, the hub completed its second research capacity-sharing project. The project focused on culturally adapted and faith-sensitive MHPSS interventions for Syrian communities. The project's findings were shared in an international webinar and a workshop aimed at Syrian practitioners. "Culturally Sensitive Mental Health and Psychosocial Support (MHPSS) in the Syrian Context: Findings Of a Research Capacity-Sharing Project" a policy paper written jointly by the JLI and Syria Bright Future (SBF) summarizes the key findings of the research.

JLI and SBF completed a further two hub publications in 2023: an annotated bibliography on MHPSS, Culture and Faith in Syrian Communities, and a report on the outcome of the listening dialogues held by the Hub in Türkiye and Syria in 2022.

In June 2023, Senior Research Fellow Dr Jennifer Philippa Eggert presented the hub's work at the Annual Meeting of the Alliance for Child Protection in Humanitarian Action, in a session on 'Supporting children on the move through community-based, faith-sensitive responses for MHPSS'. On 5 October, Jennifer presented two research capacity-building initiatives of the

JLI, including the work of the Syria Hub, at a session focusing on capacity-building, refugees and faith. Later that month, on 25 October, Jennifer and hub co-chair Dr. Mohammad Abo Hilal presented the Syria hub approach at a session on MHPSS, refugees and faith.

South East Asia Hub on Humanitarian Response, Human Trafficking, and Faith

In 2023, JLI partnered with the International Network of Engaged Buddhists (INEB) and the Spirit in Education Movement (SEM) in Thailand to establish a new Hub examining the role of faith actors in responding to migration and human trafficking at the Thai-Myanmar border.

In March 2023, INEB and SEM facilitated a Listening Dialogue at a Buddhist temple in the border town of Mae Sot, bringing together members of the temple (including the Abbott, various monks, and novices, some of whom were displaced children from Myanmar placed by their families at the temple for safety), as well as local civil society organizations and humanitarian practitioners.

Participants reflected on the need for greater coordination between faith actors who were providing front-line services to displaced children, and humanitarian and civil society actors.

Following the Listening Dialogue, INEB and SEM expanded their network of faith actor and humanitarian partners working collaboratively with the Buddhist temple in Mae Sot, with plans for further Listening Dialogues, and creative documentation (such as storytelling and videos) planned for 2024.

Southern Africa Hub on Religion and Gender-Based Violence

In 2023, JLI worked together with our member, Speak One Voice International (SOVI), to establish a Regional Hub focused on Religion and Gender-Based Violence (GBV) in Malawi and Zambia. Drawing on JLI's State of the Evidence in Religions and Development Report from 2022, SOVI identified a need for locally-led and culturally-relevant research on religion and GBV in Southern Africa.

With JLI's support, SOVI convened a series of six Listening Dialogues across Zambia and Malawi over the course of 2023, engaging with GBV practitioners, religious leaders, and survivors of GBV. The Listening Dialogues invited participants to share their experiences of GBV, the extent to which religious institutions addressed GBV in their local communities, and what they felt the research or learning needs on GBV were.

Following the completion of the Listening Dialogues in November 2023, SOVI and JLI developed plans for further research to be conducted on GBV and religion in Southern Africa, as well as to establish an Institute for Gender, Religion and Development in 2024.

Guiding Principles for a Fair & Equitable JLI

Following a series of consultations with JLI staff, consultants, Board members, and Leadership Council members, JLI developed a comprehensive set of guiding principles aimed at integrated fair and equitable practices across JLI's work. The Guiding Principles provide both practical and aspirational guidelines on how JLI can become more fair and equitable in its research and knowledge work, engagement with members and partners, communications, and organizational culture. JLI aims to publish the Guiding Principles in 2024.

ACTIVE GLOBAL LEARNING HUBS



In February 2023, after a three-month research capacity sharing project on Preventing Violent Extremism (PVE), conflict, peace, faith and youth, JLI launched the Conflict Transformation Hub. With a strong research capacity-sharing focus, the Hub brings together practitioners and activists working on peace, conflict and faith in their communities, allowing them to network, update each other about relevant research, and plan joint activities.

On 5 May, hub members Ali Raza Khan (Pakistan) and Khadija Tirha (Italy) spoke about the hub's work at a panel JLI held with the Hidden Peacebuilders Network at PeaceCon, organized by the Alliance for Peacebuilding.

In September, the Hub, previously working on an invite-only basis decided to open up to a broader membership and, in October, the Conflict Transformation Hub held its <u>first open meeting</u> with plans for regular meetings going forward. Existing members presented about the Hub's existing work and were joined by new members and friends from research and practice.

Monitoring, Evaluation, Accountability and Learning (MEAL) Hub

In 2023, the Global MEAL and Faith hub went through a change of leadership with Dan Williams (HOPE International) and Asaad Taha (Islamic Relief USA) stepping down from their roles. We welcomed Konul Vazirova Kangarli (Islamic Relief USA), Michelle Garred (Ripple Peace Research and Consulting) and Mukunda Adhikari (Transform Aid International and University of Technology Sydney) as new hub co-chairs.

Throughout the year, the Hub held a series of events on creative faith-sensitive MEAL and research methods. In March, Dr Michelle Lokot (London School of Hygiene and Tropical Medicine Warwick) spoke about decolonial feminist approaches to MEAL. In July, Dr Wanda Casillas (Claremont Graduate University) shared how Culturally Responsive Evaluation (CRE) provides a way of understanding how culture influences us as diverse MEAL practitioners. A third session was planned for December, with co-chair Mukunda Adhikari to speak on bottom-up project co-design, however this was postponed to early 2024.



Refugees & Forced Migration Hub

Between October and December 2023, the Refugee and Forced Migration Hub convened a series of roundtables exploring themes that intersect with religions, faith actors, and forced migration. Members shared practice and research on the experiences of faith actors in capacity sharing, mental health and psychosocial support, and social cohesion work for refugees and forced migrants. Speakers shared examples from different faith and cultural communities across Latin America and the Caribbean, Burundi, South Africa, Lebanon, Europe, Egypt, Iraq and Syria. The sessions were followed by discussions of possible research collaboration between present members.

RESEARCH, LEARNING AND KNOWLEDGE PARTNERSHIPS

Faith and Positive Change for Children, Families and Communities (FPCC)

Faith and Positive Change for Children, Families and Communities (FPCC) is a collaboration between UNICEF, Religions for Peace and JLI which aims to strengthen interfaith and faith-secular efforts at



influencing positive social and behavioural changes of the most marginalised children, families, and communities globally in order to improve child wellbeing. In 2023, FPCC saw a number of global developments.

- JLI signed two new agreements with UNICEF: one with the UNICEF Latin America and Caribbean Office (LACRO) and one with the Global HQ to cover the regions of South Asia (SAR), East and Southern Africa (ESAR) and West and Central Africa (WCAR). Both agreements are currently active and scheduled to end on April 30, 2024.
- Three FPCC Regional Coordinators and an FPCC Global Manager were hired in May and June as the core partners of the FPCC Initiative felt more regional representation would be helpful in ensuring progress on numerous deliverables.
- Stocktaking: The end of 2023 marked five years since the inception of FPCC. It was agreed that there was a need to gain an overview of achievements and an analysis of strengths and weaknesses in the work so far. JLI conducted a 'stocktaking' assessment and, during Q4 2023, launched three surveys designed to collect insights from individuals involved with the FPCC. Information from the surveys was used to plan an in-person hybrid two-day event in Nairobi, Kenya in January of 2024, the outcome of which will create a foundation for the future of the FPCC moving forward.

WESTERN, CENTRAL, EASTERN AND SOUTHERN AFRICA

A Multi-Faith Action Coordination Committees (MFACCs) survey was conducted to determine the level of MFACCs operationalization in Africa. The findings of the survey pointed towards a need for:

- 1. Additional support to MFACCs to ensure active participation at the country level in terms of resources and capacity building,
- 2. UNICEF country offices to actively participate in MFACC activities to build legitimacy at the country levels,
- 3. Increased Mind Heart Dialogue (MHD) training to ensure the approach is well embedded in MFACC activities,
- 4. Further mobilization and activation of FBOs to participate at the country level, and
- 5. Streamlined and frequent communication at all levels to enhance stakeholder participation.

The region conducted an annual Mind-Heart Dialogue (MHD) monitoring survey during the spring to document its implementation status in Africa. It was found that the MHD approach has been widely adopted for its unique delivery style and viability in equipping facilitators with necessary skills and tools. It was also found that there is a need for continuous capacity building with requests for increased training of country facilitators and mentorship being highlighted.

Together with the African Council of Religious leaders (ACRL), MHD facilitators in Uganda were supported with resources to roll out community dialogues and report on their experiences. While most of the facilitators had been equipped with skills, a limiting factor was that they were held behind by a lack of funds to hold dialogues in their respective spaces.

JLI, together with its regional training partner CORAT coordinated with ACRL to roll out in-person MHD refresher training in Zambia, South Sudan, Malawi, Sierra Leone and Burkina Faso. This provided an opportunity to further gather feedback on MHD implementation, expose facilitators to aspects of the reviewed MHD guide and develop action plans for the year 2024.

SOUTH ASIA

FPCC South Asia held its Regional Advisory Group (RAG) Workshop of Faith Actors for Child Rights and Well-Being, enhancing collaboration and positive change for adolescent girls on 13-15 August, 2023 in Colombo, Sri Lanka. A report on the RAG meeting was published to the JLI resource library.

The Region hosted its Mind-Heart Dialogue Training of Trainers (Regional MHD TOT) in Kathmandu, Nepal from November 27 - December 1, 2023. Organized and facilitated by partner and regional training institute Sarvodaya, the MHD TOT trained 34 trainers from eight countries in South Asia in partnership with UNICEF and Religions for Peace. Preliminary joint action planning was begun for the national rollout of FPCC. These national action plans are expected to include formation of Multi-Faith Action Coordination Committees for Children (MFACCs), national Mind Heart Dialogue facilitators training & MEAL Framework Rollout in eight countries of South Asia (India, Pakistan, Sri Lanka, Nepal, Bhutan, Maldives, Bangladesh and Afghanistan). The national action plans will be implemented throughout 2024.

LATIN AMERICA AND THE CARIBBEAN

A mapping exercise was conducted with a methodology designed to deepen knowledge on the work on children's rights carried out by FBOs in Latin America and the Caribbean. A series of virtual National Sessions were conducted with partners in El Salvador, Guatemala, the Dominican Republic and Brazil to discuss the information gathered through the survey as well as the preliminary mapping activities done in 2022. The mapping process faced some difficulties including a lack of response from some regional actors and partners and the ongoing political, social and health crisis in Haiti that made it nearly impossible to reach faith actors in the country. Despite the challenges, this second mapping exercise succeeded in gathering a significant amount of new and useful information regarding the focus of the FBOs' regional work.

A Regional Planning Committee was established with participation of UNICEF Regional Social and Behaviour Change (SBC), Religions for Peace, JLI and Arigatou. This committee has met on a regular basis to draft versions of a concept note for the Regional Forum. It has also convened meetings with global staff of the above mentioned organizations to find common ground within the partners to plan for the Regional Forum (27 and 29 February, 2024).

JLI participated in a webinar organized by UNICEF SBC in the region to present the FPCC initiative to religious leaders and FBOs. UNICEF regional SBC representative introduced the FPCC initiative and JLI presented the mapping results to the audience; due to time constraints, it was a very brief presentation of the main results and challenges identified in the Latin American and Caribbean context.

In September 2023, an introduction to the Mind-Heart Dialogue methodology for partners in the Latin America and Caribbean region was conducted. Partner CORAT, from Africa, gave a first glance on how the methodology works. JLI has since been focusing on finding a partner organization that can deliver trainings in each of the focused countries in 2024.



Women in Faith Leadership Fellowship

In 2023, JLI coordinated the pilot year of the Women in Faith Leadership Fellowship (WFLF), co-funded by the Bill & Melinda Gates Foundation and Conrad N. Hilton Foundation, in collaboration with the Centre for Public and Nonprofit Leadership and the Berkley Centre for Religion, Peace & World Affairs at Georgetown University. The ten fellows arrived in Washington, DC, in mid-April for the first engagement of the Fellowship. They spent two weeks at Georgetown University undertaking a range of courses, such as gender in development, advocacy, public speaking, resource mobilization, and leadership. They also met with Ambassador Melanne Verveer to discuss women in peace and security and visited the Center for Applied Research in the Apostolate (CARA). A public session in the Riggs Library at Georgetown highlighted the work of the cohort in Africa for the university audience.

They also made several exciting site visits, including meeting with Samantha Power (Administrator) and Adam Philips (then Executive Director of the Local, Faith and Transformative Partnerships Hub) at USAID, Victoria Kwakwa (Regional Vice President for Eastern and Southern Africa) at the World Bank, learned about women in conflict, religion, and peacebuilding at USIP, and had

meetings with CRS, the One Foundation, and the Gates Foundation.

In May, the fellows attended the World Union of Catholic Women's Organisations (WUCWO)'s General Assembly in Assisi, which included an audience with Pope Francis. In July, they participated in the Women Deliver Conference in Kigali. The Fellowship hosted its own breakfast session titled "Bridging Faith and Development to Advance Gender Equality: How Women of Faith Champion Unseen Women and Girls in Africa", in which fellows spoke about their experiences.

The fellows worked on designing their capstone projects and attended events around the United Nations General Assembly in New York in September. The Inaugural pilot cohort completed their fellowship experience by visiting events around the United Nations General Assembly in New York in September 2023.

They attended and spoke at events and meetings hosted by the Bakhita Partnership for Education, Goalkeepers, the Justice Coalition for Religion (JCOR), the UN's Multi-Faith Advisory Council (MFAC), and a Moth storytelling event. They presented their capstone projects to the Fellowship's Steering Committee on the final day of their visit and received their certificates of fellowship completion in a short ceremony.

Into 2024, the fellows are implementing their capstone projects in their countries, with projects ranging from maternal health projects to care of elderly sisters and climate adaptation initiatives. Throughout this pilot year, JLI has also designed and implemented a key monitoring, evaluation, and learning process to understand key lessons. JLI provided robust lessons learned documentation to the Steering Committee and has now finalized its involvement in the Fellowship.

Training on Religions & Development

In September 2023, JLI launched a new project, funded by Trinity Church Wall Street, aimed at developing a new college course on religions and development research for use in Anglican seminaries around the world.

JLI has partnered with the following five Anglican colleges and seminaries:

- St Paul's University, Kenya
- Leonard Kamungu Theological College, Malawi
- College of Transfiguration, South Africa
- Cathedral Institute for Education & Formation, Sri Lanka
- St Andrew's Theological Seminary, the Philippines

Using a participatory and collaborative model, JLI and the partnered institutions have been working together to develop course content covering issues pertaining to religions and development such as health, peacebuilding, climate change, and gender, as well as developing course materials to support the practical research skills of participants. The course will be aimed at seminary students, clergy, and laypeople, supporting them to engage confidently with these issues at both community and research levels.

The course will be implemented across all five institutions in 2024.

Strategic Religious Engagement

JLI is part of an ambitious three-year project funded by the Templeton Religions Trust to implement Strategic Religious Engagement (SRE) in four countries (Philippines, Ghana, Senegal, Sri Lanka). The project is led by Katherine Marshall at World Faiths Development Dialogue. There are two priority topics: 1) educational issues around social cohesion and 2) social safety nets affecting poor and marginalized communities. Year one (2023-2024) is a period of assessment and planning with landscaping research underway in the countries. In years 2 and 3, implementation of SRE projects will take place.

Faith Perspectives on Localisation and Decolonisation

JLI members made an investment (thank you to the generous sponsors of this work, which include ADRA, CORUS, ERD, Islamic Relief USA, and the Salvation Army) to conduct research into faith actors' perspectives of localisation and decolonisation. The project which is jointly led by JLI Board Member Emma Tomalin and Senior Research Fellow Jennifer P. Eggert includes surveys and stakeholder interviews aimed at exploring what localisation and decolonisation means to faith actors in the development sector, to what extent and how they incorporate these into their work, and what they have learned along the way. The research continues into 2024.

Research on Lutheran World Federation's Faith-Based Advocacy

JLI conducted some research for the Lutheran World Federation (LWF) on faith-based advocacy within the Federation. The research sought to capture stories about LWF's advocacy in the last seven years, aiming to understand the range of topics LWF advocacy has covered, identify good practice examples of LWF advocacy, examine challenges for LWF advocacy, learn more about how LWF staff understand and define faith-based advocacy, and present recommendations from the learning for future planning. The JLI team conducted interviews with 21 LWF team members and wrote a report based on the findings.

Religion and Development Journal

JLI team members Olivia and Jennifer continued to be part of the editorial committee of the journal Religion and Development. As policy and practice editors, they are in charge of policy and practice notes published in the journal. Hidden Peacebuilders Network

The Hidden Peacebuilders Network, a collaboration of researchers, practitioners and faith actors working on the role of faith actors in peacebuilding, started the year with a networking and research planning in Burundi. The meeting brought together colleagues from East Africa, South and South East Asia, Latin America, and Europe. JLI was represented by Senior Research Fellow Jennifer, board members Emma Tomalin and Jayeel Cornelio, and East Africa hub co-chairs John Okanga and Fredrick Ogenga. Throughout the year, the Network had two major funding successes and secured a total of £300,000 for joint research in Burundi, Sri Lanka, and the Philippines in 2023 and 2024, with Emma being Principal Investigator and Jayeel and Jennifer amongst the Co-Investigators of the project.
